

Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY.

1. Eligibility

This concert tickets sweepstakes is open to legal residents of North Carolina and South Carolina residing within a 30 mile radius of E.R. Plumbing Services Matthews, NC office in the United States who are at least eighteen (18) years old at the time of entry. Employees of E.R. Plumbing Services and other companies associated with the promotion of the sweepstakes, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The ending date of the concert period is Oct 5, 2017 however, the last date of drawing a winner for any of the sweepstakes will be Sept 15th, 2017.

At PNC Music Pavilion in Charlotte, NC. each entrant is required to take a photo with the mascot embedded in the wall at the venue which will be present at all large public bathrooms and shall be used as the sweepstakes submission. By entering the sweepstakes you understand that you will be automatically subscribed to our mailing list, and may receive communications from us from time to time in the future, and you expressly consent to agree to such subscription and communications.

6. Prize Drawing; Odds of Winning

On or about the 15th of each month (starting April 15, 2017), the Sponsor will select the potential winners in a random drawing, without replacement, from among all eligible entries received. The odds of being selected depend on the total number of eligible entries.

7. Winner Notification

If any potential winner does not claim the Prize within 24 hours after the date of the first attempt to contact him/her, or is disqualified for any reason, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period, that potential winner forfeits the prize. Tickets to a particular concert are not guaranteed. Tickets are subject to program availability, venue capacity, artist and age restrictions. Winner and guest(s) must abide by all venue policies. Parking, travel and accommodations not included and are the sole responsibility of winner and guest(s). 9.General Conditions

In the event that the operation, security, or administration of the sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the sweepstakes is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the sweepstakes to address the impairment and then resume the sweepstakes in a manner that best conforms to the spirit of these Official Rules or (b) terminate the sweepstakes and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.
